

General: We received a total of 276 responses, although this is less than 50% of the Association's membership, we believe this still provides a good representation of our members preferences.


One of the obvious highlights (Q8) is that almost 98% of the respondents believes that the association provides good value for money.














Approximately 40% indicted investment in existing fishings, the remainder proposed additional salmon and trout fishings. There were 30 suggestions for additional waters mixed across Dee, Don and stillwaters.

As far as our existing fishings are concerned the maintenance process has been reviewed & an additional summer beat walk by Beat Convenors to identify issues & potential improvements has been agreed.

The Committee will continue to investigate the availability of additional trout and salmon fishings that have the potential to enhance the value of being a member of the Association.






The highest number of suggestions was for the hosting of additional events (24), followed by Fees (19), Rules (10), and additional Marketing and junior engagement (6-7).

There were similar numbers of responses (6-7) for improved Access, Communication and additional events.


