Item 6.2 Proposed amendment to Constitution:

The Committee believes that in the best interests of running the Associations' affairs that the following recommended amendment is necessary:

4.0 Management

The Association shall be managed by a Committee consisting of a President, Vice- President, Past President, Secretary, Treasurer, and twelve (currently fifteen) Committeepersons, who shall form the "Committee of Management.

The Secretary and Treasurer shall hold office during the pleasure of the Association.

All other officers shall continue in office until the next Annual General Meeting, except that, of the Committee of twelve, only four (currently five) shall retire annually, and at every such meeting the said other officers shall be elected by a majority of members present and entitled to vote. On the failure of such election, those last appointed shall continue in office.
